- (1) Normal operation will be Pasadena Hardin Street Transportation (HST) to Pasadena [W] Shell Edgewater – Colex, however, when nominations from Pasadena Hardin Street Transportation (HST) to Pasadena [W] Shell Edgewater – Colex are such that sufficient pumping time exists to reverse the line, Carrier will transport product from Pasadena [W] Shell Edgewater – Colex to Pasadena Hardin Street Transportation (HST) at Shipper’s request provided Shipper tenders a minimum batch of 10,000 barrels.
- (2) This Company will assess an additional charge of [I] 16.50 cents per barrel of forty-two (42) U.S. Gallons on petroleum products transferred from Hardin Street Transportation (HST), Zachary Junction, Louisiana to Colonial Pipeline Company, Baton Rouge Junction, Louisiana.
- (3) Normal operation will be Pasadena Hardin Street Transportation (HST) to Pasadena Enterprise TE Pipeline Company, LLC, however, when nominations from Hardin Street Transportation (HST) to Pasadena Enterprise TE Pipeline Company, LLC are such that sufficient pumping time exists to reverse the line, Carrier will transport product from Pasadena Enterprise TE Pipeline Company LLC to Pasadena Hardin Street Transportation (HST) at Shipper’s request provided Shipper tenders a minimum batch of 10,000 barrels.
- (4) Primary operation is from Texas City to Pasadena. Movements originating at Pasadena and delivering to other Pasadena destinations are secondary movements. Such secondary movements will be made as operating conditions allow and scheduled at the sole discretion of the Carrier.
