No. [W] ~~36.32.0 36.31.0~~). No gathering service will be performed in association with the joint movement covered under this tariff.

Pipeline Loss Allowance

Each shipper moving under this Joint Tariff shall be subject to a single pipeline loss allowance of 0.20% for movements hereunder.
