**INCENTIVE RATE**

An Incentive Rate of **[I]** 182.86 cents per barrel will apply to the first 6,000 barrels per day, as calculated on a monthly average basis, shipped by each Shipper during a month.

**JOINT ROUTE**

POPB NM Crude II LLC (“POPB NM”) from the Phase I-C tank battery receipt points in Eddy County, New Mexico to the Interconnect with WRPL at Grayhawk, Eddy County, New Mexico (“POPB NM Segment”); then WRPL from the Grayhawk Connection, New Mexico to destinations in Winkler County, Texas (“WRPL Segment”).

For movements under this joint tariff, Carrier may impose the quality specifications of a connecting carrier or destination terminal, if the specifications for such facility or terminal are more restrictive than those established by Carrier.

**EXCEPTIONS TO WRPL’S RULES AND REGULATIONS, F.E.R.C. TARIFF NO. 1.6.0, INCLUDING SUPPLEMENTS THERETO AND SUCCESSIVE ISSUES THEREOF:**

Each Shipper shipping under this joint tariff shall pay the total pipeline loss allowance applicable to each line segment comprising Shipper’s joint movement. For movements on the POPB NM Segment, the applicable loss allowance is set forth in Item 11 of POPB NM’s F.E.R.C. No. **[W]**2-4-0 2.5.0 or subsequent reissues thereof. For movements on the WRPL Segment, the applicable loss allowance is set forth in Item 85 of WRPL’s F.E.R.C. No. 1.6.0 or subsequent reissues thereof.
