Pumpover Fee: All volumes delivered to the EPIC Crude Pipeline, LP connection in Winkler County, Texas, will be subject to a pumpover fee of [U] 10.35 cents per barrel. Such fee will be in addition to the applicable transportation rates set forth in the above table of rates.
